the goods. Its sole concern was to make sure that the shipment
itself was not prohibited under the relevant Security Council
resolutions. The question was an important one which had political
ramifications and he therefore welcomed the information provided by
the secretariat which showed that, despite occasional delays, the

Committee had considered all requests in an unbiased manner. While it might appear that a large number of requests from Jordan had been denied, that was not so proportionate to the number of requests which Jordan, a country geographically close to Iraq, had submitted.]

His Government had since consulted British exporters who were generally agreed that a time-limit of three months would be adequate for most transactions. Indeed, such a limit seemed to be working fairly well in the Security Council Committee established pursuant to resolution 724 (1991) concerning Yugoslavia, and the Committee might wish to adopt it for a trial period of perhaps six months, after which the situation could be reviewed. His delegation would support any solution which reduced the incidence of forgery while at the same time streamlining the approval process.]
