TXT[The Deputy Permanent Representative of Sri Lanka made a statement and sketched the economic consequences for his country of the crisis in the Persian Gulf. Sri Lanka had received \$25 million in aid from the International Organization for Migration to assist with the costs associated with repatriating its citizens from Iraq and Kuwait. It had also been granted approximately \$100 million in balance of payments support from various donor agencies. Further information is contained in a revised memorandum, previously circulated and also issued as S/21984.]

Economic losses, particularly those arising from the virtual cessation of oil refining in Aden, had been aggravated by a substantial reduction in external financial aid.]
