## WEEEKLY HOLDS UPDATE

## Week 29 June - 06 July 2001

## HIGHLIGHTS

- The overall holds continue to raise with no new releases
- Changes in the 1051 list to take effect shortly
- Another application for overhauling of agricultural helicopters placed on hold

1. The holds stand at **US\$3,410.0M** or some US\$85.0M more compared to US\$3.325M last week.

2. The total number of applications on hold is **1,373** (to include 924 humanitarian and 449 oil spare parts applications) or 45 more than last week. The relative value of holds was also higher in comparison to the value last week -- **15.4** percent of the total value circulated to the Committee or **12.4 percent** of the value circulated to the Committee on pre-approved lists (15.1 and 12.1 per cent respectively last week).

3. The value of oil spare parts applications on hold was marginally lower in comparison to last week's, with the total value of **US\$431.0M** on hold this week and US\$432.0M last week although the number of applications on hold in oil spares sector has gone up by 10 applications.

4. **GENERAL TRENDS:** There is little new to report on the trends during the last short week (4 July was a holiday in New York), which also saw adoption of the new resolution extending the program for additional five months. The most notable characteristic of the last week was a near absence of new releases while the holds continue to raise: only five applications were released while 50 were placed on hold; of the five applications released, one was due to an amendment deleting 1051 items and three were short holds for "pending further clarification". 5. **DURATION OF HOLDS**: Contracts Procession Section (CPS) of OIP has recently compiled statistics on the average duration of holds (based on 1,350 applications still on hold as of 3 July 2001) that show the following:

6. **CHANGES OF THE 1051 LIST TO BE FORMALLY ANNOUNCED SOON.** In practical terms, the changes will mainly affect the area of computers as the considerably raise the thresholds for inclusion in the 1051 list. This may facilitate approval of future contracts containing computers, now routinely being placed on hold, and may help in release from hold of applications containing computers that are previously assessed as being notifiable under SCR 1051 (1996). It is estimated that there are about 150 such applications currently on hold. Once the changes take effect, OIP/CPS will inform the Committee on such cases seeking either the release or change of reason for hold as appropriate.

7. **ANOTHER APPLICATION FOR HELICOPTERS OVERHAULING PLACED ON HOLD.** A second application (Comm. 900038) for overhauling of agricultural helicopters worth US\$0.65M was placed on hold for a number of reasons starting with suggestion that the goods are prohibited (SCR 687), on the 1051 list and of WMD dual use. This comes after a similar application (Comm. 900039) was placed on hold on 30 April 2001 for goods being on the 1051 list and for a set of recent photos of these aircraft. The photos were recently provided and are being forwarded to the holding mission.

8. **Total of 5 applications worth US\$7.56M** were released last week. The releases included the following:
