WEEEKLY HOLDS UPDATE

HIGHLIGHTS

- Releases continue but still topped by new holds
- Holds for end-use/user information still very high, include US28 million contract for Toyota cars
- The value of "Inactive Holds" unchanged, the value of applications pending feedback from the holding missions rises again
- 1. The holds stand at **US5,265 million** this week, to include US307.4 million in "inactive hold" category. The grand total has increased by some US38 million in comparison to the previous week's total of US5,226.8 million.
- 2. As of last week, there were 216 applications worth some US\$307.6 million in the category of inactive holds. This week the value and number of applications in this category are almost identical and stand at 215 applications worth US307.4 million. At the same time, the number of applications for which a feedback from the holding mission is due in excess of 60 days has rose again and now stands at applications worth US1,818M (558 worth US1,791M previous week).
- 3. The total number of 59% account applications on hold ("active") is 1,852 (to include 1,286 humanitarian and 566 oil spare parts applications) or 42 more than 1,820 last week. The relative value of holds has increased slightly in comparison to last week with 19.1 per cent of the total value circulated to the Committee. However, the percentage of the value circulated to the Committee AND approved by OIP based on pre-approved lists was slightly lower at 14.7 per cent (19.0 and 14.8 respectively during the previous week).
- 4. **GENERAL TRENDS:** Although the level of holds continued to increase, the rise was moderate in comparison to previous weeks. The release rate was highest for the past 6 weeks, releases mainly including applications for which additional information was provided. It is noted that in most cases the information was provided in early January and the release followed some 30 days later. This is certainly better than usual average of 8-10 weeks. However, the concern remains that very few releases or changes of reason for hold have been registered on comms. for which the information had been provided 60 days or longer.
- **5.** A NUMBER OF APPLICATIONS AGAIN PLACED ON HOLD FOR END-USE/USER INFORMATION: The observed trend of holds for end-use /user information has continued with 24 of 52 applications placed on hold containing end-use/user information as, at least, a part of the reason for hold. In 9 of 24 cases, end-use/user information was the only reason for hold. Similar to last week, this category included a single largest application placed on hold during the reporting week comm. 1001788 containing \$27.75M of Toyota cars. The reason for hold also includes "dual military use" concerns. The goods in this category this week are the

same -- vehicles, heavy machines, mobile equipment - and included the following comms:
