WEEEKLY HOLDS UPDATE

Week 2-9 November 2001

HIGHLIGHTS:

- * Holds rise again and stand at US\$4,145M to include US\$383.5M of "Inactive Holds"
- * Almost no releases during the previous week
- * Large electricity application worth US\$34.4M placed on hold
- * Three applications for service boats worth US\$22.57M placed on hold
- 1. The holds stand at **US\$4,145.0 million** this week, to include US\$383.0M in "inactive hold" category. The grand total is higher by some US\$74.0 million than the previous week total of US\$4,071.0M.
- 2. The new category of "inactive holds" includes applications on hold for which additional information was requested but not provided for more than 60 days. After a 60-day deadline, a procedure for transfer to "inactive hold" category is initiated. The applications will be held in abeyance until the requested information is provided and will then be transferred back in the "active" hold category. As of last week, there were 155 applications worth some US\$290.0 million in this category. This week the number is higher and stands at 190 applications worth US\$383.0 million. At the same time, the number of applications for which a feedback from the holding mission is due in excess of 60 days is 241 worth US\$662.0M (214 worth US\$464.4M previous week). - 3. The total number of applications on hold ("active") is **1,388** (to include 928 humanitarian and 468 oil spare parts applications) or 6 less than 1,396 last week. The relative value of holds is **16.4 percent** of the total value circulated to the Committee or **12.7 per cent** of the value circulated to the Committee AND approved by OIP based on pre-approved lists (14.4 and 11.1 respectively during the previous week). The aforementioned decline in the number of "active" holds is due to some being null-and-void (see below) and others being transferred to the "Inactive Hold" category.
- **4. GENERAL TRENDS:** While the upwards trend continued with new holds (\$84.5M), there were practically no releases during the past week, resulting in the increase in the value of holds in both relative and absolute terms. Last week seven applications on hold worth total **of** US\$9.8M were null-and-void at the request of the Government of Iraq. All seven comms have been on hold for a long time for 1051/dual use reasons and one for an explicit statement that the goods will not be

approved until UNMOVIC is back into the country. While this may not be a beginning of a new trend, it is worth noticing that the Iraqi authorities have been less inclined to null-and-void such applications in the past and would leave them in holds category for a long time. This is the first time that a medium-size batch of applications on hold was null-and-void.

- 5. A HIGH VALUE APPLICATION FOR ELECTRICITY SECTOR PLACED ON HOLD ON THE EVE OF THE 661 COMMITTEE MEETING ON THIS SECTOR: An application worth US\$34.4M (Comm. 901691) for Water Supply System in Salah al-Din project (300MW unit) was place don hold last week with the request for technical specifications on pumps, valves, control instruments, etc.
- 6. THREE APPLICATIONS FOR VARIOUS SERVICE BOATS PLACED ON HOLD: Three applications worth total of US\$22.57M were placed on hold last week, to include:
