A number of applications for trucks and other vehicles worth total

of US\$11.4M released from hold

1. The holds stand at US\$ 3,989.5 M, after briefly exceeding US\$4.0 billion last

week. The total number of applications on hold is 1,508 (1,037 humanitarian and

**471 oil spare parts**) or 21 less than at the previous report. The relative value of holds

was similar, albeit somewhat lower, to last week's percentages: 16.39 % of the total

value of applications circulated to the Committee or 12.83 % of the value circulated

to the Committee AND those applications approved by (16.89 % and 13.23 %

respectively the previous week).

2. The value of oil spare parts applications on hold was slightly higher in

comparison to last week's, with the total value of US\$ 527.0M on hold this week and

US\$524.0M last week.

3. **GENERAL TRENDS:** The level of holds has been reduced due to new

releases last week amounting to US\$179.5M and exceeding new holds (US\$114.2M)

by some US\$65.3M. Most releases pertain to trucks and various vehicles (see next paragraph). Such ration caused the level of holds to drop somewhat but it is not clear that such trend will continue. The level of new holds remains consistently high even though we are still awaiting for more complex (and, therefore, frequently subject to hold) applications under phase X.

- 4. **A NEW SET OF APPLICATIONS TO BE RE-CIRCULATED TO THE 661 COMMITTEE BASED ON FURTER REVISION OF THE 1051 LIST.** A new set of changes to the 1051 list (S/2001/561), pertaining to the "nuclear annexes", has come into effect on 1 September 2001. Based on the changes mainly affecting computers -- we have so far identified some 150 applications currently on hold that now contain no or fewer 1051 items than before the changes. Re-circulation of these to the 661 Committee will start this week.
- 5. RELEVANT PERTIES TO BE ISSUED REMINDERS OF HOLDSRELATED INFO OR ACTION STILL PENDING: In the letter to the
  Chairman of the 661 Committee dated 20 September 2001, OIP Executive Director
  stated there were 356 applications worth US\$916M that remain on hold since the
  requested information for hold had not been provided after 60 days or longer. At the
  same time, there were 244 applications worth total of US\$700M still awaiting
  feedback from holding missions 60 days or longer after the requested information had
  been provided. OIP will issue a remainders to the relevant parties urging for the
  appropriate action to be taken immediately. It is OIP's intention to maintain statistics
  on the time expired since the holds-related information had been requested/provided
  and to issue reminders to the relevant party after 60 days of inaction. This is expected
  to speed up the flow of information and, ultimately, reduce the duration of holds.

## 6. A NUMBER OF APPLICATIONS FOR VEHICLES RELEASED:

Total of **11** applications worth **US111.4M** for trucks and other vehicles in various sectors were released from hold to include several high-value applications. In most cases, the applications were on hold for additional information on spare parts, tool kits, etc. while there was no objection to vehicles themselves. The released comms include:
