THREE HUNDRED AND TWENTY THIRD REPORT OF THE OVERSEERS TO THE SECURITY COUNCIL COMMITTEE ESTABLISHED BY RESOLUTION 661 (1990) CONCERNING THE SITUATION BETWEEN IRAQ AND KUWAIT

The following report is submitted to the Security Council Committee established by resolution 661 (1990) concerning the situation between Iraq and Kuwait pursuant to paragraph 14 of the Committee Procedures, by which the Overseers were required to submit a weekly report to the Committee on the contracts considered by them with regard to sale of petroleum and petroleum products originating in Iraq, including the cumulative quantity and approximate value of petroleum authorized for export.

1. During the reporting period, 8 to 14 February 2003, no new contracts were approved.

2. In accordance with paragraphs 12 and 13 of the Procedures, 12 letters of credit and amendments for 12 liftings were confirmed by the Overseers.

3. Eight loadings, (4 from Mina-al-Bakr, 4 from Ceyhan), comprising 11.4 million barrels, (7.3 from Mina-al-Bakr, 4.1 from Ceyhan) with an estimated value of Euro 295 million were completed (\$315 million at current rate of exchange).

4. The revenue generated from the beginning of Phase XIII at current prices is estimated at about Euro 3,019 million (\$3,235 million at current rate of exchange).

5. The average price for Iraqi crude during the reporting period was approximately \$27.80/bbl or Euro 25.95/bbl.
