The following report is submitted to the Security Council Committee established by resolution 661 (1990) concerning the situation between Iraq and Kuwait pursuant to paragraph 14 of the Committee Procedures, by which the Overseers were required to submit a weekly report to the Committee on the contracts considered by them with regard to sale of petroleum and petroleum products originating in Iraq, including the cumulative quantity and approximate value of petroleum authorized for export.

1. During the reporting period, 14 to 20 December 2002, 17 new contracts were approved. (For details see, table 1).

2. In accordance with paragraphs 12 and 13 of the Procedures, 21 letters of credit and amendments for 20 liftings were confirmed by the Overseers.

3. Eleven loadings, (3 from Mina-al-Bakr, 8 from Ceyhan), comprising 13.9 million barrels, (5.2 from Mina-al-Bakr, 8.7 from Ceyhan) with an estimated value of Euro 352 million were completed (\$361 million at current rate of exchange.)

4. The revenue generated from the beginning of Phase XIII at current prices is estimated at about Euro 496 million (\$508 million at current rate of exchange).

5. The average price for Iraqi crude during the reporting period was approximately \$25.25/bbl or Euro 24.60/bbl.
